# Approval of Agenda

## Approval of Minutes

## Applicant Interviews

## Reports

Administrative Report:

Clerk Scaman reviewed with members of the Citizen Involvement Commission (CIC) the Vacancy and Chair Expiration Date Report that is provided for the Village Board monthly. Currently there are 17 vacancies out of 146 members, with 3 applicants that have been recommended by CIC. Clerk Scaman reported that an announcement for recruiting citizen involvement was in the October Village FYI that was just mailed to every residence in Oak Park. In addition, the Village Clerk has a few recent resident applications for citizen involvement and Joe Kreml has met with Chair Troelstrup to record a short social media post.

#### Old Business

Clerk Scaman demonstrated where to find the work plan for every commission on the Village website to assist with preparing for interviews. FY2018 work plans will become available after the Village Board approves them.
