**Call to Order:** Acting Chair Lipic called the meeting to order at 7:31 p.m.

#### **Agenda Approval**

It was moved and seconded to approve the agenda for the meeting. A voice vote was taken and the agenda was approved as presented.

#### **Public Comment**

There was no public comment.

# **Approval of Minutes**

It was moved and seconded to approve the minutes of the meeting of January 29, 2013. A voice vote was taken and the minutes were approved as presented.

#### **New Business**

Motion to Recommend Revised Ordinance Language to Allow Liquor Commissioner to Authorize Special Event License for Uncork Illinois Vintners

Acting Village Attorney Simone Boutet stated that the proposed E-2 Special Event Liquor License would not be specific to this particular event but would allow for special event retail vendors to bypass the process of coming before the Liquor Control Review Board. They would apply in writing directly to the Local Liquor Control Commissioner, who could then issue the license for the duration of the event only. This is compliant with state law. She asked for input regarding the concept of the license. There was an extensive discussion. Ms. Boutet would add that each licensee be granted a maximum of two of these licenses per year and asked for input regarding the limit of licenses granted during any one time.

### **Old Business**

#### Food Obsession

Owner Daniel Vogel, who also appeared at the January 29 meeting, stated that he has completed the application as well as the other required documentation for a Class A-4 Catering Liquor License. He has already opened for business.

It was moved and seconded to recommend that a Class A-4 Catering Liquor License for TZOD Vogel, Inc., d/b/a Food Obsession, be granted.

#### Olga Dailey, owner of Eastgate Café, on behalf of the Oak Park Arts District.

Ms. Daily asked about obtaining a liquor license in order to sell beer and wine at an event scheduled for September 21. She noted that she believed the Arts District was a for-profit organization. Village Clerk Powell indicated that if the Arts District is a for-profit organization, they would not be eligible for an E-1 license. Commissioner Lipic added that unless it is some type of organized or incorporated entity, they are not able to get any type of license. Ms. Dailey was uncertain as to what type of entity the Oak Park Arts District is. Clerk Powell also stated that Ms. Dailey needs to advise the LCRB as to who will be selling the alcohol. Ms. Dailey later confirmed that the Arts District is a not-for-profit entity.

# **Administrative Report**

Village Clerk Powell stated that OMG! Brunch & Boutique, LLC will occupy the old Thyme and Honey space at 100 S. Oak Park Ave. She distributed copies of the application, menu and business description. They are planning on serving breakfast and lunch. She reported that Pints has still not opened. Also, there is no further information regarding Spiro Papageorge's new restaurant.
