Then, Kinderhook Tap will be rebranded and reopened as Obsessed Kitchen and Bar. There will be approximately 10-15 full and part-time employees at Obsessed Kitchen. All employees will be BASSET trained. The restaurant hours will be 3:00 p.m. to 11:00 p.m. Monday through Wednesday, 3:00 p.m. to midnight on Thursday, 3:00 p.m. to 1:00 a.m. on Friday, 9:00 a.m. to 1 p.m. on Saturday and 9:00 a.m. to 11 p.m. on Sunday.

It was moved by Member Miller and seconded by Member Keeku to recommend to the Village Board adoption of an ordinance approving a Restaurant Class B-4 Liquor License for Obsessed Kitchen and Bar for the property at 800 S. Oak Park Avenue. The roll call was a follows:
