**Ongoing Business**

- Chairman O'Rourke started the meeting by introducing the commission to the guest member.
- Commissioner Kathleen Yannias contacted the Health Board and obtained the unofficial Community Health Plan. The plan was e-mailed to the commission. The topic was tabled until January.
- Chairman O'Rourke presented Village Clerk Vicki Scaman. Village Clerk Scaman talked about her Township and Non-for-profit experiences as well as her commission and elected experiences. She explained that she is a resource for the commission and how the commission is an advisory to Village Council. She explained that since the board is not all knowledgeable they rely on the commissions to provide research from evidence and data finding resulting in advice and suggestions.
- Chairman O'Rourke commented on the 2018 Work Plan. She mentioned how the commission will need to discuss sidewalks around construction sites. Commissioner Riley commented that the City of Chicago has laws about this topic. Clerk Scaman stated that this is an opportunity to research Chicago and other communities and possibly put forth a solution. She stated that topics can also be presented at a chair meeting and do a survey at the farmer's market to access the community's concerns. Clerk Scaman mentioned that once a topic is chosen to utilize Trustee Andrea Button, and obtain support.
- Commissioner Jen Kovar presented her report on the Awards ceremony. She stated that the event is December 13<sup>th</sup>, 2017. She is asking commissioners for a \$25.00 donation for the services rendered at the ceremony. The commission agreed to hand delivers the signed invitations to the four winners. Since Commissioner Browning was absent we had not been able to review the proposed slide show. Commissioner Kovar had also reached out to the people that nominated the winners, and the business that had not won, but been nominated
- Chairman O'Rourke commented that they'll review the 2018 Work Plan at the January meeting
