request for the Aging in Place Commission to recommend partnering with the Oak Park River Forest Township to establish a Home Repair program for small home repairs and basic maintenance. The program would be administered by the Northwest Housing Partnership. Subsidies would be funded by AgeOptions. The Township is requesting financial support to cover the administrative expenses in the amount of \$1750.
