Rosemary Malone is a co-partner of Chicago's Home of Chicken and Waffles and presented the application. Chicago's Home of Chicken and Waffles has been in business in Oak Park since 2010 and it now seeks a BYO license. They have live music on Fridays and Saturdays from 7:00 p.m. to 11:00 p.m. Many staff members are Bassett trained. BYO will enhance Fridays and Saturdays at the restaurant.

A motion was made by Member Corbin and seconded by Member Matheny to recommend approval of an Ordinance for a Restaurant Class B-6 BYO liquor license for VFJ Enterprises II, Incorporated d/b/a Chicago's Home of Chicken and Waffles.

B. Application of New Pot Restaurant, 727 Lake Street, for a Class B-6 BYO Liquor License

The main focus of the business is carry-out and delivery. New Pot previously had a Class B Restaurant liquor license. Mr. Ruengpinyophun and his sister are Bassett trained.

A motion was made by Member Kuna and seconded by Member Conniff to recommend approval of an Ordinance for a Restaurant Class B-6 BYO liquor license for New Pot Restaurant.
