
Disconnecting gutters can reduce chances of basement flooding

With the goal of reducing the chances of backups during heavy rain, the Village is encouraging property owners to disconnect their gutter downspouts from the municipal sewer system.

Storm water from roof gutters is not a problem on normal flow days with minimal precipitation. However, during heavy rain events, the main system can become overwhelmed, sometimes causing sewage and storm water to back up into basements.

Simply by eliminating water flowing from gutters into the sewer system, property owners can help reduce the

chances of a back up from the Village's combined sewer and storm water system.



In addition to reducing incidents of basement flooding, disconnecting gutter downspouts from the municipal sewer system also can offer a way to capture free water for plants, lawns and gardens.

Officials urge property owners to consider using rain barrels to store storm water for future use and creating rain gardens or using native plants in landscaping to help absorb runoff.

- Extend downspouts at least three to six feet away from the building foundation wall and direct flow away from the building.
- Pick a suitable area for the water to flow to such as a grassy area or rain garden. Route downspout extensions under decks or patios to reach these permeable areas.
- Use a splash block at the end of the extension to avoid soil erosion.
- Avoid placing an extension across a sidewalk so as not to create a tripping hazard.
- Avoid flowing water onto sidewalks or driveways since these may freeze during cold months.
- Remember to cap the sewer where the downspout once connected to prevent debris and animals from entering and odors from escaping.



Organics collection program offered

With the goal of decreasing the amount of organic refuse sent



to landfills, the Village offers food scrap composting services to residents throughout the community. The cost is \$14 per month, which is about the same as recycling one bag of yard waste per week under the current Village yard waste program that does not accept food scraps.

Participants receive a special 96-gallon mobile cart for organics, an under-sink collection bucket and a box of compostable bags for food scraps.

Subscribers who use the organics cart for their yard waste and food scraps will not have to purchase yard waste stickers for grass clippings placed into the organics cart.

Residents who maintain backyard compost piles or who mulch grass clippings are urged to investigate sharing organics carts and costs with neighbors.

Nearly 500 households currently participate in the pilot composting collection program.

Comment on new parking signs

f you park along South Boulevard between Austin Boulevard and Harlem Avenue, Parking Services wants to know what you think of the new signs. The Village is testing signs designed to be clearer and more user friendly, with the focus on providing information to individuals other than permit holders. Officials say that since permit holders are given detailed, written information on the rules that specifically apply to them when they receive the permit, they only need the lot number and type of permit allowed to park there. Avoid risks around downed power lines

Inen severe weather brings down power lines, public safety personnel urge residents to be aware of the danger. Their advice — always assume power lines are live, since even momentary contact with a live power line can injure or kill. If a power line comes down, ideally, a firefighter or police officer will stand by the site until utility workers arrive. But when emergency conditions are widespread, personnel may not be available for this level of service. In those instances, affected streets or alleys are blocked and the area around the downed wire isolated by yellow warning tape. Child safety seat inspections offered by appointment



The Fire Department has a special telephone line to accept requests for child safety seat inspections. Parents of young children can call 708.358.5604 to request an appointment for a car seat inspection by a certified technician. Requests also may be sent by e-mail to carseat@ oak-park.us. Parents will need to bring their vehicle owner's manual and car seat manufacturer's manual along with the seat they wish to have inspected. Residents are asked not to come to the Fire Department for an inspection without an appointment. As on-call firefighter/paramedics, the technicians may not be available if duty calls.

Citizen volunteers embody long history of open government

When it comes to citizen involvement in the process of making public policy, few communities can match the number of opportunities offered by the Village of Oak Park. More than 150 volunteers serving on 19 separate boards, commissions and committees advise the Village Board on a wide range of important issues.

From proposals for new developments to plans to better manage Oak Park's limited supply of parking, the residents who participate on these bodies play key roles in making sure policy enacted by the Village Board has had thorough public review and is in the best interests of the community as a whole.

Boards, commissions and committees conduct in-depth studies, evaluate research and hold meetings that create the public record for citizen sentiments on possible future policies set by the Village Board. Recommendations are made to the Village Board whose members have the statutory authority to make new local laws and regulations.

When vacancies occur on these advisory bodies, the Citizen Involvement Commission interviews those Villagers who have volunteered to serve. The commission then makes recommendations to the Village president, who makes the formal appointments with the consent of the Board of Trustees.

A varied group of volunteers is sought to represent the Village's diversity, and renters as well as homeowners are encouraged to apply. Some commissions even include a member of high school age.

Comprehensive Plan process continues



lillage property inspectors are continually checking single-family homes and apartment buildings for code violations to ensure public safety and community aesthetics as part of the Neighborhood Walk Program. Watering restrictions in effect

As part of the interstate compact for preserving the Great Lakes, summer watering restrictions are in effect May 15 through Sept. 15. Outdoor water use is limited Monday through Friday to even-numbered street addresses on even-numbered days, and to odd-numbered addresses on odd-numbered days. Residents who leave their windows and patio doors open overnight to catch a summer evening breeze could unwittingly become targets of burglars who cruise neighborhoods looking for just such opportunities. Solicitors seeking donations for charitable or not-for-profit organizations may solicit from 9 a.m. − 9 p.m., Mondays − Saturdays, except holidays. Solicitors who provide information or advocate on behalf of political, environmental or religious groups are not restricted by times and days. Commercial and non-profit solicitors must be registered with the Village and must present their permit when asked. West Nile virus threat grows

As temperatures rise, so does the threat of the mosquito-borne West Nile Virus. The best defense is to reduce the chances of mosquito bites. Recommended steps include limiting time spent outdoors between dusk and dawn, wearing long sleeves and pants, and applying insect repellent containing DEET, Picaridin or oil of lemon eucalyptus. Residents also are urged to eliminate potential mosquito breeding sites by cleaning roof gutters, emptying birdbaths and storing containers upside down when not in use. Scoville Park now offers free Wi-Fi

isitors to the recently renovated Scoville Park at Lake Street and Oak Park Avenue can stay connected with free Wi-Fi, thanks to the collaboration of the Oak Park Public Library and the Park District.

Tablet and smart phone users can check their device settings to find scovillepark and access the web



virtually anywhere in the park for free.

The new system includes multiple access points to

allow hundreds of users to surf the web simultaneously. The wireless network opplair will remain available to patrons inside the adjacent main library.

The Scoville Park wireless system was part of a year-long renovation of the venerable park that included a new playground, tennis courts, pathways, lighting and entrances, as well as extensive new landscaping. A grant from the Illinois Department of Natural Resources made the project possible.

Scoville Park, originally designed by noted landscape architect Jens Jensen, is named to the National Register of Historic Places by the National Park Service.

Nominations sought for historic preservation awards

ugust 30 is the deadline to nominate an Oak Park Property for a 2013 Historic Preservation Award. Nominations also are being sought for projects that address both historic preservation and sustainability issues.

Single-family residences, apartment buildings, commercial buildings, public/ institutional buildings and religious structures may be nominated in the categories of restoration, rehabilitation, adaptive use and additions/new construction. Additional awards are presented for stewardship, detail and design.

Projects should have been created within the past five years, and located within the boundaries of the Village, but need not be in an historic district. Interior work also may be considered in conjunction with exterior work.

Any resident, owner or tenant of eligible structures, members of local preservation and historical societies, and members of local boards and commissions may make nominations. The judges' decisions will be based upon the Historic Preservation Commission's Architectural Review Guidelines, which are based on the Secretary of the Interior's Standards for Rehabilitation, as well as considerations of contextual and design appropriateness.

Vehicle Sticker deadline near



very Oak Park resident who owns or leases a vehicle is required to purchase and display a vehicle sticker annually by midnight, July 15. Anyone who misses the deadline must purchase a sticker and pay a \$20 late fee. Failure to display a valid Village sticker by the deadline also may result in a \$50 ticket. Residents whose vehicles already are registered with the Village
