THE CLERK GAVE THE OFFENDER \$200 FROM THE REGISTER. THE MANAGER THEN APPROACHED AND WAS GRABBED BY THE ARM BY OFFENDER #2 WHO ALSO DISPLAYED A BLACK HANDGUN AND DEMANDED HE BRING HIM TO THE SAFE. THE MANAGER LED OFFENDER #2 UPSTAIRS AND OPENED THE SAFE WHILE #1 STAYED WITH THE CASHIER. OFFENDER #2 REMOVED \$2,775 USC FROM THE SAFE AND BOTH SUBJECTS FLED THE STORE AND ENTERED A WHITE CHEVY SEDAN 2007-2010 UNKNOWN LICENSE PLATE AND WERE LAST SEEN N/B ON OAK PARK AVE. LOSS ESTIMATED AT \$2,975.
