SUBJECT: 24-Hour Gas Station Analysis Update

The purpose of this memorandum is to provide the Village Board with updated information on violent crime at 24-hour gas stations.

# **Background**

On May 6, 2022, Development Customer Services and the Police Department provided to the Village Board with a memorandum on the 24-hour gas stations, authored by Director Tammie Grossman. The memorandum specified that between January 1, 2019 and April 25, 2022, twenty-one (21) criminal incidents occurred at seven of the eight 24-hour gas stations and fourteen (14) of those incidents occurred between the hours of 10pm and 6am.

On June 3, 2022, in response to a question from the Village Board, the Police Department completed an updated analysis of violent crime between January 1, 2019, and April 25, 2022 at the eight 24-hour gas stations located in the Village. The analysis found the occurrence of 16 violent offenses at 24-hour gas stations overall. The analysis also found 12 of the 16 violent offenses occurred between 10pm and 6am at only four of the eight 24-hour gas stations, and that four of the 12 violent offenses involved the discharge of a firearm. Three of the four gas stations were identified as having the highest incidence of violent offenses including: Shell at 6129 North Ave, BP at 100 Chicago Ave, and BP at 520 S. Austin Blvd.

# **Updated Information on Violent Offenses**

As of July 29, 2022, there were two additional violent offenses at 24-hour gas stations (one before 10pm and another involving the discharge of a firearm after 10pm) since the last report for an updated total of 18 violent offenses between January 1, 2019, through July 29, 2022 and now 13 of 18 violent offenses occurring between the hours of 10pm and 6am. It also reflects an increase from four to five violent offenses involving the discharge of a firearm including one murder.

The tables below include the updated summary of the violent offenses for the four 24-hour gas stations identified in the previous report. All offenses involving the discharge of a firearm are **bolded** in the tables. The BP Gas Station located at 100 Chicago Ave has the most violent offenses involving the discharge of firearms and a murder.

In response to the violence at the 24-hour gas stations, the Police Department continues to deploy increased resources to monitor specific gas station locations where violence has more often occurred.
